Tyne Stone Merchant I appoint my Wife Margaret Appleby
Executors and my son Robert Appleby to be Executors of this my Will. I
give devise and bequeath all my real and personal estate and
effects whatsoever and wheresoever unto my said Wife and son to be
holden by them Upon trust firstly by sale or mortgage thereof
or of any part thereof or by any other ways and means to raise
and pay my debts funeral expenses and the costs and charges
of proving this my Will Secondly to pay the net rents
dividends and annual proceeds of the residue of my said
property estate and effects unto my said Wife during her
life Thirdly from and after the decease of my said Wife
as to my Freehold dwellinghouse with its appurtenances
situate on the east side of William Street Arthurs Hill
Newcastle upon Tyne to convey and assure the same unto
my said son Robert absolutely and as to the remainder
of my said property estate and effects by sale or mortgage
thereof or of any part thereof or by any other ways and
means to raise and pay unto each of my daughters
Margaret the Wife of Edward Scott and Jane the Wife
of George Jeffrey the sum of One hundred pounds for
her own sole and separate use free from marital control
and for which her receipt alone notwithstanding her
coverture shall be a sufficient discharge and subject
thereto to convey assign and assure the said remainder
of my property estate and effects unto my said son
Robert and my said two daughters in equal shares and
proportions as Tenants in common absolutely the share of
each of my said daughters to be for her own sole and
separate use and benefit free from marital control
and for which her receipts alone notwithstanding coverture
shall be a sufficient discharge And I declare firstly that
the receipts in writing of my said Trustees shall be sufficient
discharges for all money to be received by them respectively
pursuant to this my Will and shall exonerate the person or
persons paying the same from all liability in respect of

The application thereof And secondly that my said Trustees shall not be answerable for the acts and defaults of each other nor for any involuntary loss and shall be at liberty to deduct and retain out of my said property estate and effects all costs and expenses which they may respectively incur or sustain in the execution of this ~~will~~ my will or in relation thereto In witness whereof I have hereunto set my hand the seventeenth day of July One thousand eight hundred and fifty six — William C.
